To elect COBRA continuation coverage, complete and sign this Election Form (EF) and return via secure email that will be sent to you by request. Under federal law, you have 60 days after your loss of coverage date to elect COBRA continuation coverage under the Plan. This form must be received no later than 60 days after your loss of coverage date. If you don't submit a completed EF by the due date, you lose your right to elect COBRA continuation coverage. If you officially reject COBRA continuation coverage via this EF before the due date, you may change your mind as long as you furnish a subsequent completed EF before the due date. If you change your mind after first rejecting COBRA continuation coverage, your COBRA continuation coverage begins on the date you furnish the subsequent completed EF.
